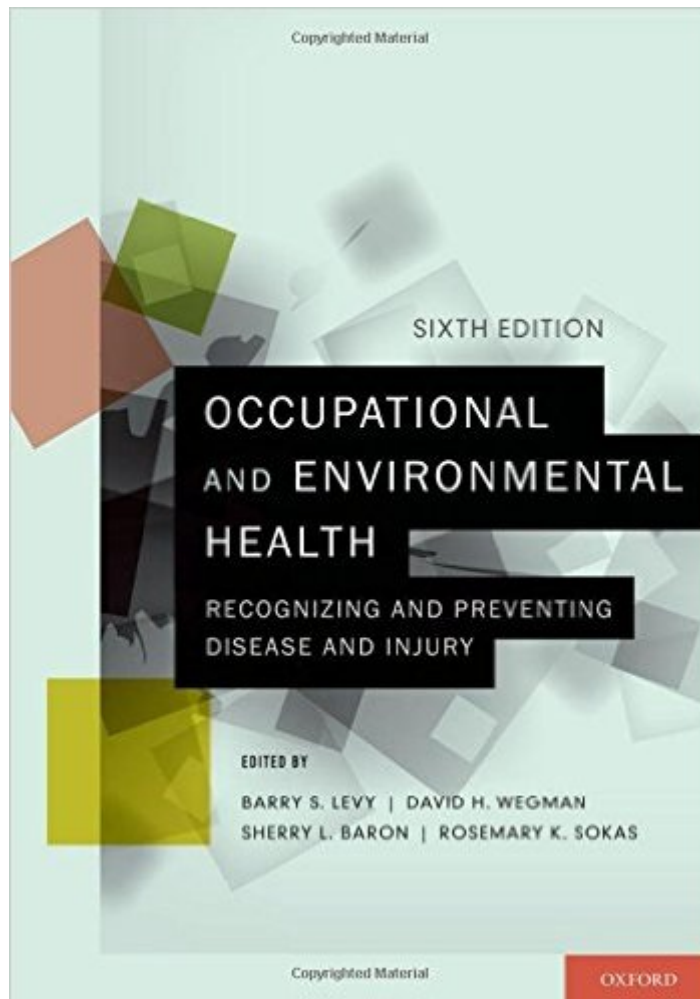

It is printed with two column per page so each column has very few words and the sentences are broken up into several lines. The text is small.
