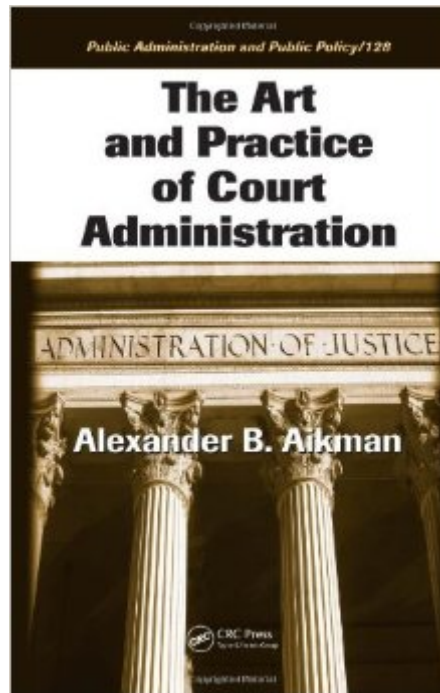

Synopsis

The Art and Practice of Court Administration explores the context in which court administration is practiced and identifies the qualities and skills court administrators need. The second part reviews a new approach for setting and adjusting priorities among the multiple functions courts perform—the Hierarchy of Court Administration. It defines priorities, analyzes court roles that establish mission critical functions, and sets an agenda for advancing courts throughout this century.
